At the banquet we will hold a brief business meeting to elect the officers and committee chairmen for 2016-2017. The slate of candidates is included in this newsletter. As you will notice, several proposed candidates wear multiple hats and new board members are always welcome. You can volunteer to be a member at large and help us as your schedule allows. There are real concerns that the board is getting older, and you know what that means, so new faces are needed to insure the organization continues.

This year our Consumer Affairs Chairman, Bill Toth, will be on the look-out for money savings opportunities for retirees. His initial focus will be on compiling the monthly, or daily, senior discount details at local businesses. He hopes to have this information ready for our July newsletter. And he is researching free or inexpensive medial screening. This information will most likely come to you via email as many times these events do not coincide with newsletter publication dates. Our Investment Chairman, John Johnson, covers several topics in his column that may help you to keep ahead of the tax man. I have found the Medical Savings Account (MSA) to be an extremely good approach to pay for

medical expenses not covered by Medicare or my secondary insurance <u>and</u> receive a tax break on State of Idaho income taxes. Things like medical appliances, stair lift purchase and related expenses, wound care supplies, dental expenses, etc.

Spring technical meeting: We held our Spring technical meeting on March 17th with guest speaker, Dr. Eric Peterson. Eric explained the importance of rare earth elements in our interconnected, electronics-filled lives – in everything from smartphones, to electric cars, to fluorescent lights and wind turbines. His team is part of DOE's Critical Materials Institute working to find better rare earth mining techniques, and figure out ways to recycle rare earths from consumer products to lessen our dependency on China, as they control the vast majority these rare elements. The INL researchers are enhancing the recovery and recycling efficiency of critical materials to improve rare earth recycling technologies and developing technologies to increase efficiencies in rare earth manufacturing. Gary Johnsen, IREA Energy Education chairman, is preparing an article on this research effort for our July Newsletter.

In addition to the technical presentation we had the opportunity to learn about two volunteer opportunities. Chuck Briggs, IREA Program Chairman, shared his experience as a SCORE member. SCORE offers the nation's largest network of free, expert business mentors. Mentors assist start-up businesses as well as help established businesses looking to improve their profit as well as improve employee and customer satisfaction. Sunny Katseanes, Tautphaus Park Zoo Education Director, and Joann Mines, IREA member and zoo volunteer, explained the many ways in which you can help make the zoo experience great for visitors and animals. There are "jobs" for every interest - from animal care (cleaning, handling, etc.) to gardening; guiding tours to helping with classes; exhibit maintenance to special events. The zoo truly has something for everyone. Joann shared her experience has a zoo educator. I am inserting the 2016-2017 Benefits contact information and brief guidance. Just cut this information out and place it in a folder with your other critical documents. It is challenging enough to handle final arrangements, and you can help out by have details on INL benefits in that critical instructions folder. P.S. Get your will up to date, and if you do not have one - GET one prepared ASAP. Community property laws do not protect the surviving spouse from the heart break that can result when "unthinking" children and relatives get pushy!

healthy. The financial summary is provided below. If you have any questions regarding the Association's finances, please contact me.



SCAM ALERT!!: MAGAZINE SUBSCRIPTION RENEWAL BILLINGS:

Beware of false bills for your magazine subscriptions!! In one of the latest, "Publishers Billing Network" at PO Box 1985, San Marcos, CA, sends bills out for magazine subscriptions that you probably already receive and for which you have paid. The Invoice (NOTICE OF RENEWAL/NEW ORDER) looks very official, along with its urging "Thank You!

Your Prompt Attention is Appreciated". Looking closer at the bargain "Price you save off the cover price", you will find it to be about twice the normal subscription price offered by the magazine. They entice you with a bottom-line "Installment" of one-half the full price...meaning you will be billed again for the other half. A check of my records indicated that I had a multi-year subscription that does not expire until over a year from receipt of this "invoice".



A search on the internet finds multiple scams like this, with many similar "Billing Companies":

Most of these seem to be located in Nevada, but also in Oregon and California. There may be others elsewhere. Most are rated "F" by the Better Business Bureau. The best way to avoid these scams is to keep careful track of magazines to you subscribe, terms of your subscription and projected expiration date, and to whom you paid the last renewal fee. Changes to INL Investment Plan: INL retirees who continue to participate in the INL Investment Plan [401(k)] managed by Vanguard should have received a brochure recently from Vanguard informing them of some changes in the way that the Plan's expenses are covered. New Department of Labor regulations require that 401(k) plan administrators provide more clear disclosure of plan fees and how they are paid. Previously, a portion of the management fees (expense ratios) collected internally by the mutual funds in the INL/Vanguard Plan came back to Vanguard to cover their costs for administering the Plan. The details of this fee structure were not well disclosed. As explained in the brochure, going forward the mutual funds in which Plan participants were invested will be replaced by similar Vanguard "Admiral" funds and Institutional Target Retirement funds with lower management fees, and each Plan participant will be charged a small (\$13) quarterly administrative fee. The brochure indicates that on

April 1, 2016 funds will be automatically moved from current mutual funds to comparable lower-fee Vanguard mutual funds - Institutional Target funds and Admiralseries funds. The expectation is that the lower fees of the replacement funds will more than offset the new quarterly administrative fee. As previously, Plan participants can change the types of funds in which their holdings are invested, but they must choose from the new slate of fund choices.

Qualified Charitable Distributions from

IRAs: Every year it seems that Congress renews a package of income tax features affecting tax returns near the end of the year. One of these has been an allowance for taking Qualified Charitable Distributions (QCDs) from retirement accounts and transferring them directly to a qualifying charity. In addition to being tax-free distributions, QCDs fulfilled the required minimum distribution (RMD) obligation. In recent years this feature was renewed near the year's end, making it difficult for

retirees to take advantage of it. However, late in 2015 Congress and the President made the QCD feature permanent, at least for 2016. Thus, retirees who must take RMDs from their retirement accounts are allowed to satisfy part or all of their RMD for 2016 by making transfers directly from their IRA or 401(k) to qualified charities, up to a maximum of \$100,000. Qualified charities are generally churches and non-profits registered with the IRS as 501(c)(3)s. The retirement account custodian will need the charitable organization's federal tax id number, as well as their name and mailing address, to make the transfer. As usual, retirees must coordinate with their retirement account custodian(s) to ensure that the total RMD obligation is met by the end of the year. Money donated by the QCD mechanism cannot be used as a charitable deduction if the retiree is itemizing deductions on their tax return.

Idaho Medical Savings Accounts: Several of us in IREA serve as volunteer income tax return preparers in the AARP Tax-Aide Program. Our interviews of tax return clients include asking if they have an Idaho Medical Savings Account (MSA); and if they occasionally pay medical expenses out-of-pocket, or separate from insurance benefits. Uninsured medical expenses may include costs of eye doctor visits, prescription glasses, dental checkups and procedures, etc. A majority of our clients seem unaware of Idaho Medical Savings Accounts. These are accounts set up at banks or credit unions specifically for paying medical expenses. Not all banks and credit unions provide these accounts, but most do. Deposits into these accounts are deductible on Idaho State tax returns, and withdrawals from these accounts must only be used for paying medical expenses. Money deposited in Idaho Medical Savings Accounts carries over to future years with no loss. An Idaho Medical Savings Account must be set up before the medical expenses are incurred that are to be paid from the account. The account may be used for medical expenses of the account owner(s), their dependents, and certain "dependent children" of the account owner that may not be claimed as dependents (e.g., grandchildren).

Beginning with tax year 2014, the maximum deduction for deposits into Idaho Medical Savings Accounts was increased to \$10,000 for single taxpayers and to \$20,000 for couples filing jointly. Since medical insurance premiums are also deductible separately on Idaho tax returns, these premiums should not be paid from the medical savings accounts. Withdrawals from the medical savings account for purposes other than eligible medical expenses must either be re-deposited into the account within 60 days, or the withdrawal must be reported as taxable income on that year's tax return and a 10% penalty is incurred. If the account owner is 59 ½ or older, the 10% penalty is waived.

Social Security Benefits Changes: Special thanks to IREA Vice-President, Pat Marushia, for researching changes to Social Security that can impact younger retirees - 66 and under.

Federal budget legislation for 2016 passed by Congress and signed by the President last fall included two changes to somewhat obscure Social Security benefits strategies used by some couples to increase their retirement income from Social Security (SS).

File and Suspend: The first strategy involved the higher-earning spouse filing for SS benefits and immediately suspending their benefit while continuing to work. The lower-earning (or non-working) spouse could then file for a spousal benefit, i.e., half of what their higher-earning spouse would be getting. After a few more years of working, the higher-earning spouse would then retire and receive a higher SS benefit. The lower-earning spouse may also have continued working and eventually receive a higher SS benefit based on their own work record. After May 1, 2016, a lower-earning (or non-working) spouse cannot file to receive a 50% spousal benefit <u>until</u> their higher-earning spouse actually begins to receive a SS benefit. If a couple has already begun this strategy by May 2016, they may continue it.

<u>SO</u> - if you turn age 66 within six months after the law is enacted (the law was officially signed on Monday 11/2/15 so you must reach age 66 by May 1, 2016), you can still file and suspend benefits allowing your spouse and dependents to receive benefits on your earnings record. BUT after May 1, 2016 no one will be able to collect benefits on another person's earnings record unless that "earner" is actually receiving SS benefits – in other words retired and drawing SS.

Restricted Application: The second strategy no longer permitted for many is referred to as "Restricted Application." This strategy involved a spouse who was eligible for both a 50% spousal benefit and a benefit based on their own work record. This spouse could choose the spousal benefit and delay receiving a higher benefit based on their own work record until reaching age 70. This strategy is only permitted in the future for people who turned 62 before the end of 2015. Basically, people born before January 1, 1954 will be grandfathered in for the restricted application strategy.

These two strategies for augmenting SS benefits were not well known nor widely used by most SS recipients and are not described on the SS web site. A paper describing these strategies and the recent changes imposed by the budget legislation that Pat Marushia obtained from the Social Security Coach Blog is posted on the IREA web site (www.inlretirees.org).
