Dr. Mark Peters, INL Director, addressed the Fall General meeting. As Dr. Peters completes his first year as INL Director, he shared the INL vision and mission that drives BEA and guides the maturation of INL as a multi-program national laboratory.

Vision: INL will change the world's energy future and secure our critical infrastructure

Mission: Discover, demonstrate, and secure innovative nuclear energy solutions, other clean energy options, and critical infrastructure.

Dr. Peters shared examples of the increase of INL's new in-town research facilities and planned enhancements to established in-town research facilities as well as plans for new and refurbished facilities at Materials and Fuels Complex (MFC), formerly ANL-West, and Test Reactor Area (TRA).

Complex-wide infrastructure enhancements: The in-town Engineering Research Office Building (EROB) is now part of the large Research and Education Campus (REC) that includes the Center for Advanced Energy Studies (CAES),

six new buildings dedicated to National Security research and testbeds, and plans for two new facilities – the CyberCore Integration Center and the Collaborative Computational Center. REC focuses on collaborative research with regional universities, industry, and other national laboratories. The Idaho Research Center (IRC) will undergo updates to its 20+ year old laboratories over the next few years aligned with a push to revitalize INL's basic research and development capabilities in support of the nation's energy needs.

MFC has and is undergoing facility upgrades allowing for enhanced transient testing, analytical analysis, post-irradiation examination, advanced characterization, fuel fabrication, and space nuclear power and isotope technologies. The Transient Reactor Test Facility (TREAT) is in the process of being refurbished and brought back on-line. Dr. Peters thanked the retirees involved with TREAT for an excellent facility that was "mothballed" with supreme care allowing it to be readied again for research use. The MFC five-year plan includes two new facilities – the Research Collaboration Facility and the Sample Preparation Facility – as well as a new utility corridor.

Enhancements to TRA keep INL in the forefront of steady state neutron irradiation of materials and fuels aligned with the needs of the naval nuclear propulsion program, industry, national laboratories, and universities. Life-extension of the Advanced Test Reactor (ATR) is currently underway with the goal of adding additional decades to its serviceable life through 2050. Planned new TRA facilities include the ATR Science and Engineering Facility and the Remote Handled Low-Level Waste (RHLLW) Facility.

Pillars of INL success: Enhanced infrastructure is vital for INL to achieve simultaneous excellence as a research, development, demonstration, and deployment (RDD&D) national laboratory. Scientific and technical excellence, operational excellence, and community excellence are the vital pillars needed for INL success.

Operational excellence covers those services needed by all INL employees – security, transportation, maintenance, fire prevention and firefighting, etc. For example care has been taken to modernize and upgrade the bus fleet with a focus on energy efficiency and reduced emissions.

Community excellence involves active in community and regional outreach, support of local events, and charitable efforts.

Scientific and technical excellence focuses on enterprise-wide interdisciplinary RDD&D. INL is actively involved in Gateway for Accelerated Innovation in Nuclear (GAIN) through a private public partnership model. GAIN integrates global technology leadership and global industrial leadership to optimize use of nuclear energy within a clean energy portfolio to help remove barriers to cleaner, safer nuclear energy sources. INL is involved in enabling small modular reactors (SMR) to become a reality with the potential of the siting of a NuScale SMR at INL. INL works with vendors and industry on the development and deployment of SMRs through its involvement in Utah Associated Municipal Power Systems (UAMPS), a not-for-profit group of 45 community-owned power systems in eight western states. Collaborations with universities and industries move INL into collaborative research efforts to provide innovations for clean energy systems.

In the National Security arena, INL provides innovations in cyber and physical security organized around the CyberCore Integration Center. This Center provides

- Mitigation capabilities and testbeds covering controller protocols, wireless and dynamic spectrum, embedded system exploitation, and emulations and visualizations,

- Large scale validation at INL's full-scale critical infrastructure test range complex and Network on Chip (NOC) demonstration center, and
- Long-term R&D challenges in critical energy management systems.

CAES provides scientific and technical core capabilities in energy systems design and analyses, nuclear science and engineering, materials science and engineering, environmental and resource sustainability, carbon engineering, geological systems and applications, and energy policy. Over the past six years CAES R&D has resulted in \$131.M in funding and equipment, 3,754 students supported by CAES-related projects, and 1051 publications, presentations, and proceedings by CAES researchers.

Q&A: During the Q&A session Dr. Peters encouraged retirees to share the work they did and what goes on at INL. We need to help friends and neighbors understand the facts about the laboratory and advocate for INL. He shared that there will be a renewed emphasis on the basic research role of INL by revitalizing areas such as chemistry, physics, and materials R&D.

Year-End Financial Issues: As we approach the end of 2016, a few items of concern to retirees should be reviewed. For those who have reached, or will soon reach the age of 70½, the issue of required minimum distributions (RMD) from tax-deferred retirement accounts [IRAs, 401(k)s, etc.] is of concern. Those who reached this milestone in past years should be well aware of the RMD. The custodians of these tax-deferred accounts inform their clients in January of what their RMD is for the coming year, and often pester their clients who haven't yet taken their RMD. Failure to take the RMD from tax-deferred retirement accounts when required can result in a penalty of 50% of the RMD shortfall.

If a person owns two or more such accounts, they should receive an RMD notice from each account custodian. In the case of IRAs, RMD withdrawals don't have to be taken from

each account, but the total of all withdrawals must at least equal the total of all IRA RMDs. For retirees who still have a 401(k) account and one or more IRAs, distributions from their IRA(s) cannot satisfy the RMD for the 401(k), since 401(k)s are employer-sponsored retirement accounts, treated differently from IRAs by the IRS. An RMD for a 401(k) must be taken from the 401(k) account.

Most or all of the distributions from these retirement accounts are treated as ordinary income on tax returns. Thus, it is prudent to request that the account custodians withhold some of the distribution for federal taxes, perhaps 20% or more, to avoid a large tax bill next spring and possible penalties.

Retirees beginning to take RMDs from retirement accounts are likely to see more of their Social Security benefits being taxable, perhaps as much as 85% of their SS benefits.

Thus, it may be prudent to increase the voluntary tax withholding on their SS benefits.

One way to reduce income tax on RMDs from IRAs is to take advantage of an income tax feature renewed in December 2015 that applies for all of 2016 and possibly into future years. This feature is an allowance for taking Qualified Charitable Distributions (QCDs) from IRAs and transferring them directly to a qualifying charity up to a maximum of \$100,000. In addition to being tax-free distributions, QCDs help fulfill the RMD obligation for IRAs, but not for 401(k) accounts. Those who have not yet fulfilled the IRA RMD obligation for 2016 can still take advantage of the QCD allowance. Such distributions must be made directly from the account custodian to the qualifying charity. Qualified charities are generally churches and non-profits registered with the IRS as 501(c)(3)s. The retirement account custodian will need the charitable organization's federal tax id number, as well as their name and mailing address, to make the transfer. Money donated by the QCD mechanism cannot be used as a charitable deduction if the retiree is itemizing deductions on their tax return.

Several of us in IREA serve as volunteer income tax return preparers in the AARP Tax-Aide Program. In performing this service, we occasionally encounter situations with retirees where lack of knowledge or lack of attention to financial matters causes difficulty in preparing a tax return or an undesired outcome of the tax return. These problems can usually be avoided by proper advance planning and recordkeeping during the tax year. Good recordkeeping

practices for investments are encouraged for all taxpayers. Keep records of all past stock, mutual fund, and real estate purchases, as well as dividend reinvestments.

For taxpayers who may wish to itemize deductions rather than using the standard deduction, it is important that they keep good, detailed records throughout the year of all medical expenses, including medical insurance and travel mileage for treatments, all donations to charitable organizations, property tax payments, mortgage interest, and sales tax on major purchases such as cars. Even if the taxpayer expects to use the standard deduction, records of a few expenses should be kept that receive beneficial treatment on the Idaho State tax return. These latter items include medical insurance, long term care insurance, deposits into Idaho Medical Savings Accounts and Idaho College Savings Accounts, donations to educational entities (schools, public TV & radio), and donations to youth and rehab organizations (e.g., Idaho Youth Ranch, the ARC, and the Development Workshop). Donations to educational entities must be in cash, but donations to youth and rehab organizations may be cash or non-cash goods in sellable condition. Keeping receipts for these donations is important.

Many taxpayers forget to bring along their previous year's tax return and supporting documents when coming to a tax return preparer. The previous year's return is important in assuring that the current return includes all of the various types of income received (dividends, interest, pensions, IRA withdrawals, W-2 salary) as well as properly factoring in any capital loss carry-forward information.

Walk-ins are welcome, or "senior citizens" can make an appointment by calling 528-8887. Appointments allow us to staff more effectively and provide you with assistance with a minimum of waiting.

It is extremely important that all taxpayers bring last year's tax return with them because we will be using a new tax return software program. In past years, some information from the previous year's return auto-loaded upon entering the taxpayer's Social Security number - allowing your new return to be completed more quickly and helped us avoid overlooking important data inputs. This "carry-forward" data is not available with the new software program, so all information must be input manually into the new return.

VOLUNTEER OPPORTUNITY: Community members are needed to volunteer on the Board of Directors of the Foster Grandparents of Southeast Idaho (FGSEI).
