Fall General Meeting:

On October 17, 2018, Dr. George Griffith, INL's Small Modular Reactor (SMR) Research, Development, and Deployment Manger, provided an update of activities currently underway on SMR's. The proposed design, construction, licensing. and operation of an SMR on the INL site made this a timely subject for INL Retirees.

Dr. Griffith is a relationship manager at Idaho National Laboratory and the lead for Technical Business Development & Marketing. He works on technical analysis and interfaces with the nuclear industry to develop new projects. He was the Thermal Science and Safety Analysis group manager, Light Water Reactor Sustainability



Advanced Fuels Pathway Lead and worked on the ATR methods upgrade project, fuel cycle calculations and LEU conversion studies. His primary focus is working on nuclear projects and advanced calculations for the reactor core design and licensing. Prior to working for INL, he was a reactor engineer and reactor engineering manager at Cooper Nuclear Station. Dr. Griffith has many years of experience in commercial nuclear fuels fabrication, core design, core operations and nondestructive evaluation while at Global Nuclear Fuels.

He holds a Ph.D. in nuclear engineering from North Carolina State University and a B.S. in nuclear engineering from Iowa State University. Dr. Griffith (on the right in the photo) meets with Chuck Briggs, IREA Program Chairman, prior to the technical presentation.

SMR's can range in size up to 300 MWe and are envisioned to be deployed as single or multiple reactor units at the same site to meet specific power demands. The smaller reactor units provide the ability to factory-assemble the reactors and critical components in modules that are shipped to the site where they are installed and loaded with fuel. Some designs could be fabricated and fueled at the factory, sealed, transported to the site, operated, and returned to the factory for defueling at the end of life, thus minimizing transportation and fuel handling.

The SMRs demand less on-site preparation and construction significantly reducing upfront capital costs and construction times when compared to large reactors (>1000MWe). Additional SMRs can be installed at the site to meet increasing electrical demand or for alternate energy uses (e.g. process heat, desalination, etc.). The smaller size also allows them to fit on existing electric grids with few changes and to be installed in areas with minimum infrastructure support.

SMRs are designed to be inherently safe having a high dependence on passive systems to mitigate accidents. Construction of some designs below-grade in large pools with all primary components, including steam generators, installed in a single containment vessel provides a simpler and more robust design during unplanned events.

NuScale is presently scheduled to design, build, and operate an SMR on the INL in conjunction with Utah Associated Municipal Power Systems (UAMPS). The NuScale design consists of twelve 60 MWe units (for a total of 720 MWe) in a single below-grade installation. Fuel for the reactor is standard PWR fuel, 5% enriched. The design relies on natural circulation in its operational mode. During an unplanned event, reactor cooling is provided by gravity driven circulation, passive decay heat removal, flooding of the containment, and air cooling for long-term heat removal. No external power for emergency systems or operator actions are needed to stabilize the system.

NuScale is expecting the NRC licensing application submitted in 2016 to be approved by 2020. INL supported the plant license safety evaluation using RELAP-5 3D to perform the calculations. Numerous sites on the INL were reviewed for siting the reactor. Four locations have been selected with the preferred site being South of the "puzzle" (US 20/US 26 junction) and North of the Big Southern Butte. Evaluation of the site for DOE licensing is scheduled to start in 2019. NuScale will need a land use agreement for DOE to host a commercial nuclear reactor. The reactor is scheduled to be on-line in 2026.

In addition to NuScale INL has had initial or development discussions with other vendors using a number of other reactor designs including molten salt, gas cooled, pebble bed, and fast reactors. INL has also had discussions on Micro Reactors (<20 MWe) concepts with vendors.

Scammers follow the news – and the money. A few months ago, we shared the news that Medicare is sending new cards to everyone who gets Medicare benefits, replacing your Social Security number with another number. As expected, scammers have been trying to cash in on this change.

These scammers typically reach out by phone and have tried a few different tactics. Sometimes, they claim to be a Medicare representative and ask to verify (ahem, steal) your information. Or they claim that there's a fee for your new card (there isn't). Others claim that your Medicare card was compromised and you need to move your money from your bank into "safer accounts" (it wasn't, you don't, and following their advice means putting your money in their pockets). We've even heard of some scammers offering plastic versions of the card for a fee – even though the real Medicare cards are paper and there are no legitimate plastic cards. How can you avoid these scams? Remember these tips:

- Don't give personal information to get your new Medicare card. If someone calls claiming to be from Medicare, asking for your Social Security number, bank information, or other information to get your new card, that's a scam. Hang up. Medicare will never
- ask you to give personal information to get your new Medicare number and card.
 Don't pay for your new card. It's yours for free. If anyone calls and says you need to pay for it, that's a scam. Hang up.
- If you've already given out your bank account information over the phone, talk to your bank immediately. You'll want to deal with any unauthorized activity on your account as soon as possible.

Year-End Financial Issues

As we approach the end of 2018, a few items of concern to retirees should be reviewed. For those who have reached, or will soon reach the age of 70½, the issue of required minimum distributions (RMD) from tax-deferred retirement accounts [IRAs, 401(k)s, etc.] is of concern. Those who reached this milestone in past years should be well aware of the RMD. The custodians of these tax-deferred accounts inform their clients in January of what their RMD is for the coming year, and often pester their clients who haven't yet taken their RMD. Failure to take the RMD from tax-deferred retirement accounts when required can result in a penalty of 50% of the RMD shortfall.

One way to reduce income tax on RMDs from IRAs is to take advantage of an income tax feature for taking Qualified Charitable Distributions (QCDs) from IRAs and transferring them directly to a qualifying charity up to a maximum of \$100,000. In addition to being tax-free distributions, QCDs help fulfill the RMD obligation for IRAs, but not for 401(k) accounts. Those who have not yet fulfilled the IRA RMD obligation for 2018 can still take advantage of the QCD allowance. Such distributions must be made directly from the account custodian to the qualifying charity. Qualified charities are generally churches and non-profits registered with the IRS as 501(c)(3)s. The IRA custodian will need the charitable organization's name and mailing address, and may also need their federal tax id number, to make the transfer. Money donated by the QCD mechanism cannot be used as a charitable deduction if the retiree is itemizing deductions on their tax return.

Since the standard deduction on tax returns has been greatly increased, fewer people will be itemizing deductions this year. However, a few specific types of donations or money transfers can be of significant advantage to taxpayers on their state income tax returns, even if using the standard deduction. These latter items include deposits into Idaho Medical Savings Accounts and Idaho College Savings Accounts, donations to educational entities (schools, public TV & radio), and donations to youth and rehab organizations (e.g., Idaho Youth Ranch, the ARC, and the Development Workshop). Deposits into Idaho Medical Savings Accounts are deductible on the state return up to \$10,000 for single filers and \$20,000 for joint filers. Deposits into Id. College Savings Accounts are deductible up to \$6000 for single filers and \$12,000 for joint filers. Donations to educational entities (must be in cash) and donations to youth and rehab organizations (may be cash or non-cash goods in sellable condition) can provide tax credits on the state return. Keeping receipts for these donations is important.

Retirees who hold mutual funds in taxable accounts should also be aware of a common practice for these funds to make dividend distributions and capital gains distributions near the end of the year, and most often these distributions are reinvested. If the investor intends to sell such mutual funds, it's important to wait at least a month after any dividend reinvestment to avoid the complications of such reinvested dividends showing up as "wash sales" on subsequent 1099-B forms used for their tax return.

Investments - continued

Several of us in IREA serve as volunteer income tax return preparers in the AARP Tax-Aide Program. In performing this service, we occasionally encounter situations with retirees where lack of knowledge or lack of attention to financial matters causes difficulty in preparing a tax return or an undesired outcome of the tax return. These problems can usually be avoided by proper advance planning and recordkeeping during the tax year. Good recordkeeping practices for investments are encouraged for all taxpayers. Keep records of all past stock, mutual fund, and real estate purchases, as well as dividend reinvestments.

BEA or FLUOR retirees with a Finance or Benefits question but you are not sure whom to contact: INL has set up a dedicated retiree phone number you can use to reach a human or leave a voice message 208-526-0717. And a retiree-dedicated email box at retiree@inl.gov to which you can send a message. The e-message is read and directed by a human to the appropriate HR or Finance POC who can answer your inquiry.

Address change or phone number: If you change your address or phone number, remember to alert HR of those changes via written notification.

Financial institution change: If you receive a monthly pension payment from INL's Retirement Plan and need to make a change in your bank account information or have a question about your deductions, contact Joseph Drasso, Finance POC.

If you did elect life insurance coverage: General questions about life insurance should be directed to your HR point of contact.

Remember, when you retired, the insurance policy was a benefit you had to elect to take and pay for monthly from your pension check. If you have no monthly life insurance premium deduction from your INL monthly pension payment, you DO NOT have this insurance coverage. If you did elect this coverage, the life insurance carrier is Prudential Insurance. They can be reached at 1-800-562-9874, and INL's group number is 44274. Be sure to contact the insurance carrier if you need to change beneficiaries on your policy. Also include life insurance contact information in your important papers so the person handling your estate has clear guidance on this policy.

When you need to contact Human Resources (HR) or Finance, we suggest that you:

- First send an email that clearly states your question be sure to include both your email address and phone number in the email text.
- Give the POCs listed above a minimum of <u>one (1) full business day to respond</u>. THEN call and leave a voicemail message, if you do not reach the person. In that voicemail explain that you have sent them an email detailing your question.

He worked as a Directorate Fellow and department manager of the Nuclear Science & Technology, Thermal Sciences and Safety Analysis Department at the Idaho National Laboratory. Carl was an internationally recognized researcher with over one hundred publications and four patents. He was awarded the INL Laboratory Director's Award for Exceptional Engineering Achievement, the Federal Laboratory Consortium Outstanding Technology Department award and the Stoel Rives Innovation award for energy technology for his work in hightemperature co-electrolysis. Carl was an invited international researcher at the Institute of Fluid Mechanics, University of Erlangen, Germany.

Linda L. Snarr (76) passed away 9/24/18. She worked at CWI as a secretary from 10/1/94-1/30/06.

Allyn R. Phillips (87) passed away 9/24/18. Allyn worked for Westinghouse, EG&G, Lockheed Martin and Rockwell, where he was awarded Nuclear Engineer of the year for his work on the M-1A1 Abrams Tank. He later retired from EG&G.

Lyle G. Dickerson (78) passed away 9/25/18. He worked for INL in the early 60's in nuclear research.
